The representative/owner of any and all firearms that will be auctioned by McLemore Auction Company, LLC shall deliver any and all auctioned firearms to **APPS dba High Caliber Weaponry & Training** located at 2611 Lebanon Pike, Nashville, TN 37214. **APPS dba High Caliber Weaponry & Training** shall at that time enter any and all firearms delivered or received to **APPS dba High Caliber Weaponry & Training** in their FFL book as required by current Federal Law Regulations. An inventory of the firearms shall be made at the time of delivery and such inventory copies shall be given to the assigned representative of McLemore Auction Company, LLC. The Academy of Personal Protection and Security (**APPS dba High Caliber Weaponry & Training**), and its employees and or agents shall not be responsible for any damage/theft/destruction to any of the firearms left in their possession.

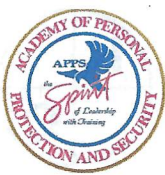
FIREARMS SHALL "NOT" BE READY FOR TRANSFER UNTIL THE AUCTION IS COMPLETE!

A **NON-REFUNDABLE** fee of \$45.00 shall be paid in cash, money order, or by credit or debit card (credit/debit cards have a 3% convenience fee added), this fee shall be paid in **ADVANCE** and will **NOT** be refunded. If the registered buyer or firearm does not pass the background check, there will be **NO** refunds. If the buyer purchases more than one firearm, the cost will be \$45.00 for the first gun and \$10.00 for each additional firearm. Any firearm abandoned at **APPS dba High Caliber Weaponry & Training** for more than five (5) business days, beyond the completion of the auction, the purchaser will pay a fee of (\$5.00) per day storage for the firearm(s) left in the care of **APPS dba High Caliber Weaponry & Training**. If the firearm(s) remain in **APPS dba High Caliber Weaponry & Training** possession after 60 days, the firearm(s) will be considered **abandoned**, and the purchaser/buyer will **forfeit all weaponry/ firearm(s)**. No refunds or reimbursements of any kind will be issued. If the registered buyer cannot successfully pass the background check, the firearms shall be kept in possession of **APPS dba High Caliber Weaponry & Training** and resold at the next appropriate McLemore Auction Company, LLC or disposed of at McLemore Auction Company, LLC legal discretion. It shall be the registered buyer's responsibility to contact McLemore Auction Company, LLC regarding the fees on the firearms.

IMPORTANT PLEASE COMPLETELY READ PAGE 2 AND SIGN!

- The registered auction buyer is the **ONLY** person legally allowed to receive the firearm(s) purchased. No Exceptions. No relative, friend, or any other person can legally receive or pick up the firearm(s).
- All purchasers of any firearm(s) **MUST** have this signed agreement.
- All purchasers of any firearm (s) **MUST** have their pre-paid receipt from McLemore Auction Company, LLC in their possession to legally be allowed to pick up or transfer any firearm.
- Purchaser must have printed receipt proof of purchase from McLemore Auction Company, LLC to pick up any firearm(s).
- Handgun: You **MUST** have a valid State of Tennessee driver's License. If you are from out of state (non-Tennessee resident) you **CANNOT** legally receive a handgun in the State of Tennessee. The handgun shall be shipped/delivered to an FFL Dealer of your choosing in the state of your residency.
- Long gun: If the firearm is a long gun, you may receive it from **APPS dba High Caliber Weaponry & Training** at the above address. You **MUST** have a valid State License or Government issued identification.
- Shipping: All shipping fees of any financial value, along with the transfer fees, shall be the responsibility of the purchaser. **ALL** fees **MUST** be paid in full before shipping.
