This confirms that on September 24, 2014 I carefully examined the following described jewelry on behalf of:

**Taylor White 4500 Granny White Pike Nashville, TN 37204**

The estimated value is for insurance replacement purposes and is current retail excluding all taxes.

**Report #P-425**

1. Lady's high polished 18 karat white gold Longines™ quartz movement watch enclosed in a 21 mm long by 19 mm wide by 5 mm thick oval case with a white dial which has twelve white gold stick hour markers and two white gold index hands under a synthetic sapphire crystal. It is soldered to an 18 karat white gold 11-1/2 mm to 10 mm wide by 2-1/2 mm thick high polished and rope design bracelet with a fold-over clasp and an internal safety completing the 6-1/2 inch length. The case is surrounded by twenty-eight round brilliant cut diamonds in four-prong settings in a 23 mm long by 21 mm wide oval bezel. The diamonds measure 1.9 to 2.0 mm in diameter each and weigh an estimated 3/4 carat together; they are (VS<sub>2</sub>-SI<sub>2</sub>) clarity and (G-H) color. The watch is assembled of die-struck and cast components and is stamped on the case back L7 186 18K 750 and with the Swiss assay marks for 18 karat gold. It is in very good to excellent condition (shows very light wear); appears to be in working order and weighs 43.7 grams complete.


ESTIMATED REPLACEMENT COST: \$12,000.00

2. Man's high polished stainless steel and yellow gold plated trim Movado™ watch with a 33 mm diameter by 6 mm thick round case attached to an integral 18mm wide by 3 mm thick matching bracelet with a concealed double deployment clasp. The watch has a black dial with a yellow round concave disk at the "12" position and two yellow pitched dauphine style hands covered by a synthetic sapphire crystal; it also has a hooded yellow base metal crown at the right side. The watch is etched on the bracelet STAINLESS STEEL R431.G.5 and is stamped on the case back with MOVADO 81 G2 870 [serial number] 5023931 and STAINLESS STEEL WATER RESISTANT SAPPHIRE CRYSTAL. The watch is in very good condition and appears to be in working order; it weighs 88.3 grams complete.

ESTIMATED REPLACEMENT COST: \$1,000.00

The subjectivity of appraising allows some variations in grading and valuation with alternate appraisals. This appraisal has been prepared in conformity with generally accepted professional standards following the Code of Professional Ethics of the National Association of Jewelry Appraisers and the Uniform Standards of Professional Appraisal Practice (USPAP); it is incomplete without the cover page and the limiting conditions statement.
